After you have read the Terms of Service, to proceed to the next page you must agree to these terms by selecting the “Agree to TOS and Continue” button at the bottom of the page.

We are now on the “IACRA – User Profile Information” page.

You must successfully complete each section on this page.

The first section you will need to complete, is the “Certificate Information” box. Provide your:

The second section you will need to complete, is the “Personal Information” box. Provide your:

- Full Name (and suffix if applicable), but please note: The total length of your first, middle, and last names must be less than 50 characters.
- You also have the option to provide your SSN. If you choose not to use it please select “Do Not Use”
